The Declaration is hereby amended to include and incorporate new Section 22, to read as follows:

Section 22. All platted lots within the subdivision shall be used solely for single-family residential dwellings and for no other purpose except that individual residential dwellings, if used as a rental property, shall be rented or leased for a period of not less than a three (3)
