## CERTIFICATE OF AMENDMENT AND FIRST AMENDMENT TO THE REVIVED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

## WITNESSETTI:

WHEREAS, the Declaration of Covenants, Conditions and Restrictions, dated March 14, 1985, was recorded on March 22, 1985, in Official Records Book 736, Page 50 of the public records of Santa Rosa County, Florida (the "Declaration"):

WHEREAS, the Declaration was revived and recorded on April 27, 2023, in Official Records Book 4389, at Page 356 of the public records of Santa Rosa County, Florida ("Revived Declaration"). All references to the Declaration herein shall include the Revived Declaration;

WHEREAS, in accordance with Article VIII, Section 3 of the Occlaration, the Declaration may be amended by an instrument signed by the owners of not less than seventy-five percent (75%) of the owners in accordance with the voting rights specified in Article III of the Declaration; and

WHEREAS, a duly noticed meeting of the members was held on September 20, 2023, at which not less than seventy-five percent (75%) of the votes of the Owners was received in accordance with Article VIII, Section 3 of the Declaration approving this Amendment to the Declaration.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Declaration is amended as follows:

The Declaration is hereby amended to include and incorporate new Article VII, Section 17 to read as follows:

Section 17. All platted Lots within the subdivision shall be used solely for single-family residential dwellings and for no other purpose except that individual residential dwellings, if used as a rental property, shall be rented or leased for a period of not less than a three (3) consecutive month period. This restriction shall take effect immediately upon the recording of the First Amendment to the Revived Declaration of Conditions and Restrictions for Paradise Bay.

WHEREAS, all provisions of the Declaration not amended hereby shall remain in full force and effect.
